Irina V. Alekseyeva holds a degree of Doctor of Arts and is a Professor and the Chair of the Music Theory Department at the Ufa State Zaghir Ismaghilov Academy of the Arts. She is a member of the Dissertation Council at the Magnitogorsk State M. I. Glinka Conservatory. She defended her dissertation for the Candidate of Arts (PhD) degree in 2002 while being a Research Associate of the Research Laboratory for the Problems of Musical Semantics at the State Institute of Art Studies in Moscow, and in 2006 she defended her dissertation for the Doctor of Arts degree at the Novosibirsk State M. I. Glinka Conservatory. She is the author of the monographic work "The Typology of Basso Ostinato Themes in the Instrumental Music of the Western-European Baroque" (Ufa, 2005). Her field of research interests includes issues of the semantic organization of musical text, as well as those of musical poetics, semiotics and the problem of interaction between the musical text and the performer.

**Elena Yu. Andruschenko** holds a degree of Candidate of Arts (PhD) and is an Associate Professor of the Rostov State S.V. Rachmaninoff Conservatory. Alexander I. Demchenko is a Doctor of Arts, Professor and Chair of the regional Dissertation Committee of the Saratov State L. V. Sobinov Conservatory. Vladimir D. Gusev is currently a senior researcher and leader of the research group at the Data Analysis Laboratory at the Institute of Mathematics, the Siberian Branch of Russian Academy of Sciences. He studied music theory and graduated from the Moscow Institute of Physics and Technical Sciences and received a degree of Candidate of Arts (Ph.D.) from the Institute of Mathematics SB RAS.

Sobinov Conservatory, an instructor of organ and harpsichord at the same conservatory and a concertizing organist. She graduated from the Saratov State Conservatory, where she studied piano, and the Hochschule Musik und Theater in Hamburg, where she studied organ, harpsichord and early music.
